User Choice Funded – Queensland Government (Traineeships)

Traineeships are funded by the Queensland Government under the User Choice Policy 2020-2021. User Choice provides a public funding contribution towards the cost of training and assessment services for eligible Queensland Apprentices and Trainees. Student contribution fees are set under this policy at \$1.60 per nominal hour. These fees will be reviewed annually by the Queensland Government and may be altered at various times throughout your training at their discretion. In circumstances where a student undertakes more than one apprenticeship or traineeship at the same time, the student will only receive funding for the government contribution fee for the qualification nominated in the first Training Contract registered.

Please Note: Apprentices and Trainees, including SATs (School-Based apprenticeships-traineeships), can only receive a maximum of two government funding contributions under the current User Choice Policy.

The total funded amount is \$4,935 for this qualification (excluding Student Contribution Fees)

Students will be notified in writing if any changes to the student contribution fees are made

Non-Funded Full Fee

Students enrolling into the Fee for Service will be invoiced in increments as they progress through their training (*This is detailed within in the participant handbook*) The \$500 Enrolment and Resource Fee will be invoiced at time of enrolment.

HLTAID003 – Provide First Aid is not charged in the course fee. Students must enrol with another provider prior to completing stage 3 to complete this unit of competency, *please note this unit is required to be refreshed (completed again) every 3 years.*

Once payment has been received AADA will organise practical components of the course to be assessed in the workplace. All Students must complete min 300 hours of work either vocational placement (*non-paid work experience – AADA will assist with finding a placement however students are required to contact Industry as well to endeavour to find a placement*) or paid work within a Dental Practice

RPL – Formalise your Skills Program – it is recommended to be eligible for RPL that you have worked within the industry previously/currently. Please speak with an AADA staff member to confirm eligibility.
